OFFICE MEMORANDUM

Subject:- Filling up of the post of Senior Private Secretary in Enforcement Directorate on deputation basis – regarding.

It has been decided to fill up the post of Senior Private Secretary in Pay Matrix level-8 (Rs.47600-151100) on deputation basis in the Directorate of Enforcement at Hqrs. New Delhi.

- 2. In terms of the Recruitment Rules, following Stenographers of Central Government are eligible:
 - i. Holding analogous posts on regular basis in the parent cadre or department; or
 - With two years regular service in level-7 (Rs 44900-142400) in the pay matrix or equivalent.

The departmental Private Secretary in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of the Central Government shall ordinarily not exceed three year.

The maximum age limit for appointment by deputation shall not be exceeding 56 years, as on closing date of receipt of applications.

- 3. The pay & allowances and other terms will be regulated in accordance with the Department of Personnel & Training's O.M/No.6/8/2009-Estt(Pay-II) dated 17th June, 2010 as amended from time to time. Besides the official working in Directorate of Enforcement at the level of Senior Private Secretary are currently entitled for Special Incentive Allowance @ 20 % of Basic Pay.
- 4. The Cadre Controlling Authorities are requested that applications of eligible and willing Private Secretary / Senior Private Secretary may be forwarded in the proforma annexed so as to reach the Joint Director (Admn.), Directorate of Enforcement, 6th Floor, Lok Nayak Bhawan, Khan Market New Delhi 110003 within 30 days from publication of this advertisement in the Directorate of Enforcement's website www.enforcementdirectorate.gov.in.

- 5. While forwarding the applications, the Cadre Controlling Authorities shall verify and ensure that the particulars furnished by the applicants are correct and no disciplinary case is either pending or contemplated against the officer concerned. The following documents should also be sent along with the applications:-
 - (i) Bio data
 - (ii) Complete and up-to-date C.R. dossier for the last five years up to 2017-2018 or attested photocopy thereof
 - (iii) Vigilance Certificate/Clearance
 - (iv) Integrity Certificate/Clearance
 - (v) Cadre Clearance
 - (vi) A statement of major/minor penalties, if any, imposed upon the officer during the last 10 years.
- 6. Incomplete applications or applications not received through proper channel or applications received after due date are liable to be rejected. However, the applications forwarded by the Cadre Controlling Authorities after the due date which were received by the CCAs within the cutoff date will also be considered. The candidate will not be allowed to withdraw their candidature subsequently on any ground.
