OFFICE MEMORANDUM

Sub:- Filling up the post of Enforcement Officer in the Enforcement Directorate in Pay Matrix Level-8 (Rs.47600-151100) on deputation basis-reg.

It is proposed to fill up the posts of Enforcement Officer in Pay Matrix Level-8 on deputation basis in this Directorate of Enforcement at Delhi, Mumbai, Chennai, Kolkata, Jaipur, Surat, Bhubaneswar, Chandigarh, Lucknow, Jalandhar, Srinagar, Bangalore, Cochin, Hyderabad, Guwahati, Ahmedabad, Goa, Madurai, Calicut, Raipur, Indore, Nagpur, Dehradun, Jammu, Shimfa, Allahabad, Ranchi, and Vishakhapatnam.

- 2 The following categories of officers having sufficient experience in collection and processing of intelligence as well as in investigation work are eligible for appointment to the post of Enforcement Officers on deputation basis -
 - (i) Inspector of Central Excise/Customs/ Preventive Officers with three years of service in the grade;
 - (ii) Inspector of Police, Central or state Police Organizations (including Central Bureau of Investigation) with three years service in the grade.
 - (iii) Inspector of income Tax with three years service in grade;

The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly deputationists shall not be eligible for consideration for appointment by promotion.

(Period of deputation including period of deputation in another ex-cadre post held immediately preceding the appointments in the same or some other organization or department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the date of receipt of applications).

Note:- (for the purpose of appointment of deputation basis, the service rendered on a regular basis by an officer prior to 01.01.2006, the date from which the revised pay structure based on the Sixth Central Pay Commission recommendations has been extended, shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.)

- 3. The Pay & allowances and other terms will be regulated in accordance with the Department of Personnel & Training's O.M. No. 6/8/2009-Estt (Pay-II) dated 17th June, 2010 as amended from time to time. Besides the officers working in Directorate of Enforcement at level of Enforcement Officer are currently entitled for Special Incentive Allowance @ 20% of Basic pay.
- 4. The Cadre Controlling Authorities are requested that applications of eligible and willing officers may be forwarded in the proforma annexed so as to reach the Joint Director (Admn.), Directorate of Enforcement, 6th Floor, Lok Nayak Bhawan, Khan Market, New Delhi – 110003. - 5. While forwarding the applications, the Cadre Controlling Authorities shall verify and ensure that the particulars furnished by the applicants are correct and no disciplinary case is either pending or contemplated against the officer concerned. The following documents should also be sent along with the applications:-
 - (i) Bio data
 - (ii) Complete and up-to-date C.R. dossier for the last five years upto 2016-2017 or attested photocopy thereof
 - (iii) Vigilance Certificate/Clearance
 - (iv) Integrity Certificate/Clearance
 - (v) Cadre Clearance
 - (vi) A statement of major/minor penalties, if any, imposed upon the officer during the last 10 years.
- 6. Incomplete applications or applications not received through proper channel may not be considered. This is an open vacancy circular. The complete applications received by 30th of every month shall be considered for selection in the subsequent month for available vacancies. This process will continue till all the vacancies are filled up.
