 - (II) With five years service in the grade rendered after appointment thereto on a regular basis in post in level 6 of the pay matrix level possessing qualifications/experience laid down as under are eligible to apply for the post:-
- (B) (I) Possessing Master's degree of a recognized University in Hindi with English as a compulsory or elective subject or as the medium of examination at degree level Or
 - (B) Master's degree of a recognized University in English with Hindi as a compulsory or elective subject or as the medium of examination at the degree level.
 - (C) Master's degree of recognized University in English. With Hindi medium and English as a compulsory or elective subject or as the medium of a examination at the degree level.

(D) Master's degree of a recognized University in any subject other than Hindi or English. With English medium and Hindi as a compulsory or elective subject or as the medium of a examination at the degree level.

Or

(E) Master's degree of a recognized University in any subject other than Hindi and English with Hindi and English as a compulsory or elective subjects or either of the two as a medium of examination and the other as a compulsory or elective subject at the degree level.

And

- (F) Recognized Diploma or Certificate Course in Translation from Hindi to English and vice versa or three years experience of translation work from Hindi to English and vice-versa in Central or State Government office including Government of India undertaking.
- 3. The Pay & allowances and other terms will be regulated in accordance with the Department of Personnel & Training's O.M.No. 6/8/2009-Estt (Pay-II) dated 17th June, 2010 as amended from time to time.
- 4.
