Filling up of the post of Upper Division Clerk in Enforcement

Directorate on deputation basis - regarding.

It has been decided to fill up the posts of Upper Division Clerk in Enforcement Directorate in Level - 4 (Rs. 25500 – 81100) on deputation basis in the Directorate of Enforcement at Delhi, Mumbai, Chennai, Kolkata, Chandigarh, Jaipur, Lucknow, Patna, Jalandhar, Srinagar, Bangalore, Cochin, Hyderabad, Guwahati, Ahmedabad, Goa, Madurai, Calicut, Bhubaneshwar, Raipur, Surat, Indore, Nagpur, Bhopal, Dehradun, Jammu, Shimla, Allahabad, Ranchi, Mangalore, Vishakhapatnam and Shilong.

In terms of the Recruitment Rules, the following categories of officers are eligible:-

Amongst Official of Central Service

- Holding analogous posts on regular basis in the parent cadre or department, or
- Lower Division Clerk in level 2 (Rs. 19900-63200) having at least 08 years' service in the grade rendered from the date of appointment thereto on a regular basis in any Central Government Departments.

The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation/absorption. Similarly, deputationist shall not be eligible for consideration for appointment by promotion.

(Period of deputation (including short term contract) including period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or Department of the Central Government shall ordinarily not exceed three year.)

The maximum age limit for appointment by deputation (including short term contract) shall not be exceeding 56 years as on the closing date of receipt of applications.

3. The pay & allowances and other terms will be regulated in accordance with the Department of Personnel & Training's O.M/No.6/8/2009-Estt(Pay-II) dated 17th June, 2010 as amended from time to time. Besides the official working in Directorate of Enforcement at the level of Upper Division Clerk are currently entitled for Special Incentive Allowance @ 20 % of Basic Pay

- 4 The Cadre Controlling Authorities are requested that applications of eligible and willing Lower Division Clerks/ Upper Division Clerks may be forward in the proforma annexed so as to reach the Joint Director (Admn.), Directorate of Enforcement, 6th Floor, Lok Nayak Bhawan, Khan Market New Delhi 110003.
