G.S.R. (E).-- In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the Ministry of Finance, Department of Revenue, Directorate of Enforcement, Assistant Director (Official Language), Group 'A' Post, Recruitment Rules, 2017, namely:-

1. **Short title and commencement:** (1) These rules may be called the Ministry of Finance, Department of Revenue, Directorate of Enforcement, Assistant Director (Official Language), Group 'A' Post, Recruitment (Amendment) Rules, 2022.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the Schedule to the Ministry of Finance, Department of Revenue, Directorate of Enforcement, Assistant Director (Official Language), Group 'A' Post, Recruitment Rules, 2017, under column 2 & 11, for the entries relating thereto, the following entries shall be substituted, namely:-

Note 1: The Departmental officers in the feeder category who are in direct line of promotion shall not be eligible for consideration for appointment on deputation and similarly, the deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: Period of deputation (including short-term contract) including the period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same of some other organization or Department of the Central Government shall ordinarily not exceed three years.

Note 3: The maximum age limit for appointment by deputation (including short-term contract) shall be not exceeding 56 years as on the closing date of receipt of applications.
