Applications are invited from eligible candidates for filling up one (1) vacancy in the grade of Additional Director of Enforcement (Prosecution), Level-13 of Pay Matrix [PB-4 of Rs. 37,400 - 67,000 with Grade Pay or Rs. 8700 (pre-revised)] on deputation basis in the Enforcement Directorate, New Delhi.

I. In terms of Recruitment Rules, the following categories of officers are eligible:

- II. The Departmental officers in the feeder grade who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.
- III. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation or Department of the Central Government shall ordinarily not to exceed four years.



- IV. The maximum age limit for appointment by deputation (ISTC) shall be not exceeding 56 years, as on the closing date of receipt of applications.
- 2. The Pay & Allowances and other terms will be regulated in accordance with the Department of Personnel & Training's OM No. 6/8/2009-Estt(Pay-II) dated 17th June, 2010 and as amended from time to time. Additional Director (Prosecution) is also entitled to grant of Special Incentive Allowance (SIA) @ 20% of Basic Pay.
- **3.** Additional Director of Enforcement is expected to be able to coordinate and oversee the intelligence and investigation matters relating to FERA, FEMA and PMLA. However, he/she may be assigned any other function by the Director of Enforcement like review, special investigation and technical work. Therefore, the officer is expected to have an in-depth knowledge of FERA, 1973 (since repealed), FEMA, 1999, PMLA, 2002 and other allied Acts and an aptitude for this type of work.
- 4.
